V Important – please read the following Terms & Conditions before filling the skip

No 'special waste' - the following items may **not** be deposited in the skips:

Asbestos, refrigerators/freezers, fluorescent tubes, television sets/monitors, tyres, batteries, gas bottles, oils, fats/greases, glues, paints, chemicals, carcasses, animal wastes, clinical wastes.

If any of the above are found in your skip they will either be rejected and returned to you or disposed of in a manner correct under current legislation (in accordance with the Environmental Protection Act 1990) and which will attract an additional charge payable by you. Drums or large containers can only be accepted if cut into smaller pieces. No fires.

1. All skips are held at the risk of the Hirer from the time of delivery to the time of collection and the Hirer shall be liable for any loss or damage caused to the skip or to any Third Party during that time.
2. If you require the skip to be sited off the main highway, we accept no responsibility for any damage caused to pavements, driveways, footpaths, gateways, other property, trees, telephone wires, etc.
3. A permit must be obtained to site skips on the highway, this will be arranged on your behalf. The highways authorities currently charge £65 (no VAT) for a permit covering 14 days on-road. An additional charge of £25 for an early start fee for permits required within three working days. Skips situated on-road must be coned and lit during the hours of darkness, these items will be supplied but it is the Hirer's duty to ensure they remain in place and to report thefts or malfunction.
4. In order to prevent debris falling off during transit the skip must not be loaded above the top of the sides
5. The hire period shall be not longer than one calendar month from the date of delivery – thereafter by prior arrangement only
6. Payment is required on delivery for all non account holders and no skip will be removed until paid for in full
7. Where no person is available to sign, then placement of the order is taken as acceptance of these conditions. Any problems or difficulties please notify within 24 hours – Ryedale Skip Hire Ltd - (01751) 477460
